The courses in this curriculum provide an overview of Kansas Medicaid with the following courses; Early & Periodic Screening, Diagnosis, & Treatment (EPSDT) mandate; Eligibility Combo(Eligibility & HCBS Eligibility); Grievance, Appeals, & State Fair Hearings(G/A/SFH); History of KS I/DD Institutions; History of KS Managed Care; Introduction to Healthcare Codes & Claims; Introduction to Medicaid Managed Care; Medicaid & Children's Health Insurance Program(CHIP) State Plans; Medicaid Overview; Medicaid Waivers; Presumptive Medical Disability Team(PMDT); Working Healthy/Work Opportunities Reward Kansans(WORK)(WH/WORK) & Work Incentives.
