Building Trust Initiative: Changing the Perception of Aging Services

Earlier this year, the LeadingAge Board of Directors recommended the creation of a long-term initiative designed to change public attitudes and evoke positive public perceptions of aging services across the continuum.

The initiative will be founded on solid research; the research and discovery phase of the project is underway. Our researchers have spoken with providers and staff, services caregivers, academics, LeadingAge leaders and sponsors, marketing experts, and current and potential customers to assess their understanding and viewpoints. We will soon conduct a national poll to learn from a broader audience; the poll will explore message frames and specific language. With these learnings, we will formulate the initiative, including producing resonant messages, identifying effective messengers, and developing compelling materials.

We will invite LeadingAge Board members, state partners, members, and coalition partners to participate—and will reach out to influencers, thought leaders, policy makers, and other stakeholders to leverage our learnings in support of aging services providers and the dedicated people who care for Americans as they grow older.
