Purpose and Objectives

Now more than ever your voice matters. With federal staffing mandates being released and an inadequate Medicaid reimbursement formula, your representatives need to hear from you, your team, your residents, and their families.

Without fierce advocacy to change the course, staffing minimums could be catastrophic to the field. This same fierce advocacy is going to be critical in Kansas to keep the current additional Medicaid reimbursement. The convergence of these two things will shape the future of long-term care for Kansas and the future survival of your organization.


Know who your legislators and federal delegates are. Type in your address on <u>Plural</u> <u>Policy</u> to find out!
