

## October 28, 2021 Update for Local Partners Q&A

<p>Are there any studies on MIS-C after getting the COVID vaccine?</p>	<p>I just did a very quick search and found a small case study: <a href="https://wwwnc.cdc.gov/eid/article/27/7/21-0594_article">https://wwwnc.cdc.gov/eid/article/27/7/21-0594_article</a> and a report in one adult: <a href="https://casereports.bmj.com/content/14/7/e243888">https://casereports.bmj.com/content/14/7/e243888</a>.</p>
<p>If we draw up the entire vial of Moderna, can we syringe to syringe transfer all 28 booster doses to get around the "vial may only be punctured 20 times"?</p>	<p>No, it is currently limited to 20 doses per vial by the EUA</p>
<p>If we did the pre order, did we have to add that again to this order?</p>	<p>No, if you placed an order for 300 or increment of 300, you do not need to add that again to weekly orders. It has been ordered for direct shipment to you.</p>
<p>We have questions about how Moderna inventory is decremented in WebIZ and how we are to waste doses. For example, when we receive 1 vial into our inventory, it appears as 10 doses. If we administer 5 regular doses and 10 booster doses out of the vial, it appears as 15 doses but only 10 were initially received. I have reached out to WebIZ through a couple of different channels and they haven't been able to provide me an answer yet. <p>Immunocompromised individuals get another dose 6 months after the third dose?</p>	<p>Yes, that is correct as of updated guidance yesterday.</p>
<p>The WebIZ inventory for Moderna was sent as 14 doses/vial. <p>If pt had J&amp;J primary and received Moderna booster dose and they are Immunocompromised they can get a 2nd booster dose after 6 months?</p>	<p>No, only the one booster after 2 months post J&amp;J</p>
<p>If a high-risk group ( healthcare, &gt; age 65, etc., not immunosuppressed) - received initial vaccine dosing of Pfizer or J&amp;J - and now requests Moderna booster - Is the booster a full dose or a 1/2 dose?</p>	<p>0.25mL - 1/2 dose</p>
<p>I know we can give Flu and COVID vaccines at the same time. Does this mean same day, or can the flu be given one day and the COVID the next week?</p>	<p>Same day and no interval, so yes, they could be given a day apart. COVID-19 vaccines may be administered without regard to timing of other vaccines. This includes simultaneous administration of COVID-19 vaccine and other vaccines on the same day. It is not known if the reactogenicity of COVID-19 vaccines is increased with coadministration, including with other vaccines known to be more reactogenic, such as adjuvanted vaccines. When deciding whether to administer an(other) vaccine(s) with a COVID-19 vaccine, vaccination providers should consider whether the patient is behind or at risk of becoming behind on recommended vaccines, their risk of vaccine-preventable disease (e.g., during an outbreak or occupational exposures), and the reactogenicity profile of the vaccines.  <a href="https://www.cdc.gov/vaccines/covid-19/clinical-considerations/covid-19-vaccines-us.html#Coadministration">https://www.cdc.gov/vaccines/covid-19/clinical-considerations/covid-19-vaccines-us.html#Coadministration</a></p>

Who do I contact about this?</p>	<p>We are aware of this issue but need specifics as these are related to the CVS and Walgreens administration of some stores not being reported. <p>Any idea if the CTP will be extended past the end of the year?</p>	<p>We will be discussing this over the next week or so as we define the strategy moving forward.</p>

The Pfizer vials which we have are marked as expiring on the vial label 10/31/21. Has there been any extension of this dating?	No
Has any information been shared as to when the OSHA rule is expected to be published on employer vaccine mandate?	We do not have specific information about the OSHA rule. We have been told it could be within the next couple of weeks, but there are a lot of steps, so it is just not totally clear.
For medical staff who have had 2 Moderna's, then got COVID, when can they get the booster shot? wait 28 days after infection or 90 days?	They can be vaccinated when out of isolation window if feeling OK.
Can we report into HHS on a daily basis or are you only looking at Wednesdays?	There are daily reporting requirements and weekly reporting requirements. The weekly monoclonal antibody uses and on hand is a Wednesday required and through the therapeutics portal portion.
Are hospitals allowed to give a prophylactic infusion?	Yes, consult the appropriate EUA for details and restrictions.
We have been reporting our MAB usage on Mondays, does it need to be actually updated through HHS on Wednesday specifically, or just once weekly?	HHS says by 11:59 p.m. on Wednesdays.

In looking at the Moderna wastage charts, it looks like half doses are essentially treated as full doses - so if 8 half doses are given out of a 14-dose vial, confirming that we report it as 6 doses of waste instead of 10 doses of waste?	Yes, but when mixing it changes it slightly.
Nursing home that is no longer requiring staff, residents or visitors to mask anymore. Is that okay with CMS guidelines?	The CMS and CDC guidelines for long term care require masking as part of infection control practices.
With brain fog, fatigue, depression long haul side effects, are there specific antidepressants or treatments being recommended?	I'm not aware of specific treatment guidelines, but I do know that KU Health System has a "Long-Covid Clinic" specifically for that population.
