

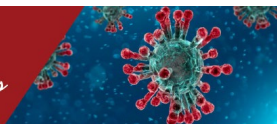

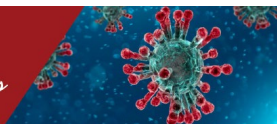

# State Update

**Executive Orders renewed until May 28th – including temporary nurse aides**

21-12 [Licensure, Certification, and Registration for persons and Licensure of “Adult Care Homes” during state of disaster emergency](#)

- New provisions:
  - Sub Sec 3 extends deadlines for CE
  - Sub sec 4 waives late fees associated with licensure
  - Facilities & locations – policy is the same but after determination of state of emergency takes additional day extensions out of EO
  - Previous EO suspended right to meet and participate in groups but that is not in this EO

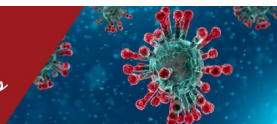

# Legislative Update

[HB 2126](#) on way to Governor – 10 day clock has not started ticking yet

[Senate Substitute for HB 2062](#) requires county owned nursing homes and hospitals to allow all visitation even in a public health emergency and even when prohibited by CMS or CDC

[HB 2114](#) establishing senior care taskforce passed Senate, now going to conference committee

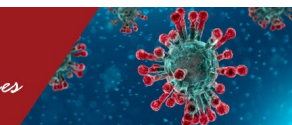
When House and Senate pass different versions of the same bill they sit down to negotiate in a "conference committee". If they reach agreement the House and Senate vote on the conference committee report.

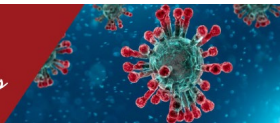

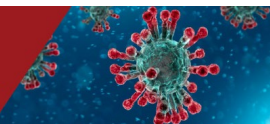
