#### State Update

- BACHA Votes to Extend 2020 LNHA Renewals to June 30, 2021
- State of emergency ends May 28th last day for TAs to work
- Spark Fund audits to start in next few weeks (5% sample)
- Medicaid eligibility processing phone lines open again, now accepting direct calls from nursing facilities
- CARE/PASSR reminder: Extension ends June 21st, by that date a PASSR must be on file for anyone entering your facility
- KDADS plans to post updated vaccine and testing guidance after Memorial Day

## Federal Update

#### American Rescue Plan (ARP) funding guidance released last week

- All funds must be spent by 2026
- Researching timelines and options in Kansas at state and local levels
- Stay tuned for more details and member discussions

#### **Provider Relief Funds updates** (Read national article <u>here</u>)

- Unless HHS or Congress takes action to change this, providers must use all PRF dollars they
  have received by June 30, 2021 for their coronavirus expenses and lost revenues incurred
  up until that point. LeadingAge and others advocating for one year extension
- Portal still not open to apply for next round of relief funds
