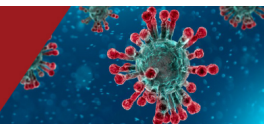

State Update

- Still waiting on CMS approval of \$15/day payments
- KDADS has begun the waiver amendment process to enact the protected income limit increase to 300% of SSI
- Preparing legislative testimony for next week on Board of Cosmetology and the issue of salon licensing in adult care homes

Federal Update

- HRSA sending out emails announcing opening of PRF reporting portal. First reporting due date is September 30th.

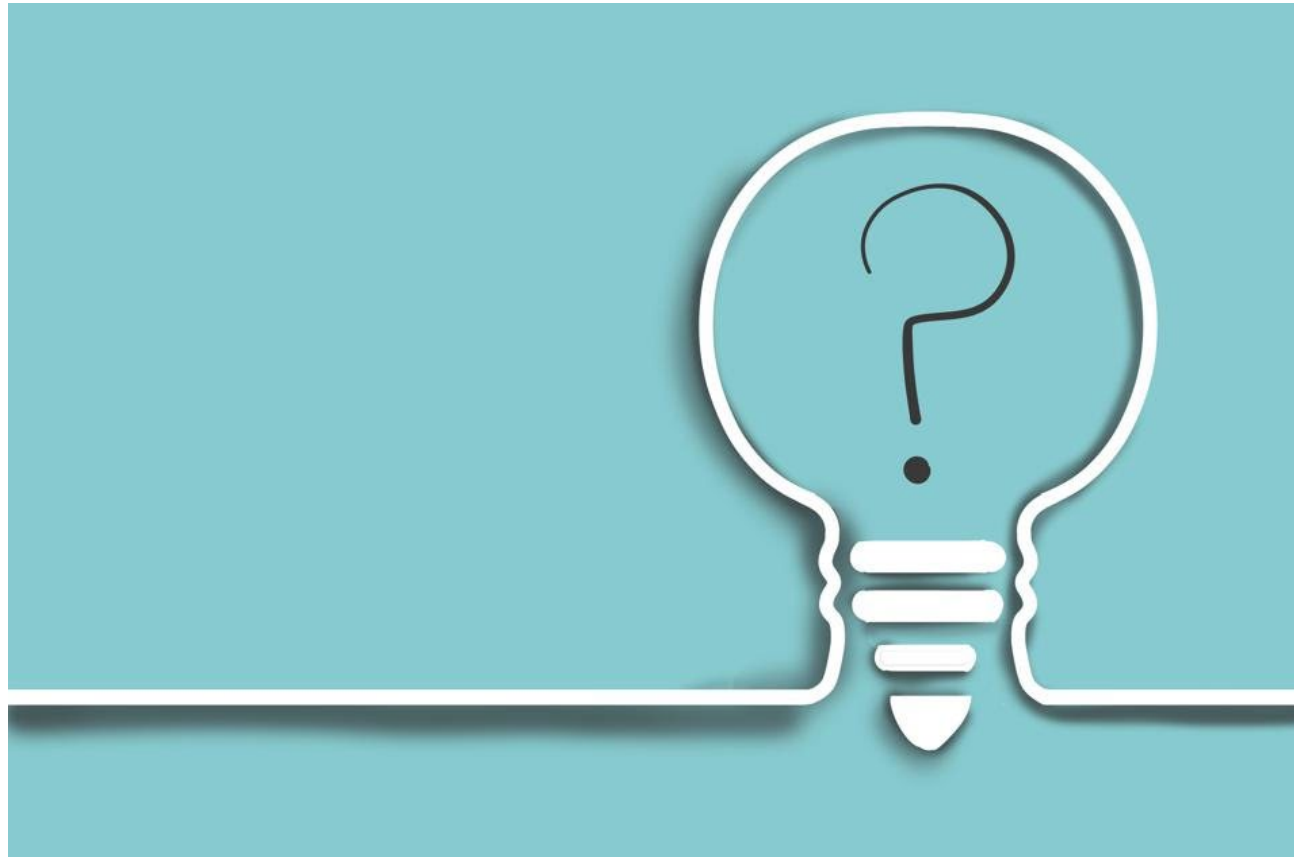
