# What is Advocacy?

Any action that speaks in favor of, recommends, argues for a cause, supports or defends, or pleads on behalf of others. Lobbying is only one kind of advocacy. Other advocacy strategies include:

- •Building and educating the grassroots
- Educating policymakers
- •Developing research and data
- •Mobilizing with rallies, meetings, etc.
- •One-on-one meetings
- •Public messages-letters to the editors
- •Social media

### Why Advocates Are Needed

- Elected officials legislate by personal stories

   Compelling stories prompt action.
- Members need to "hear from home."
   Constituents have an impact. You are VOTERS!
- Legislatures: run by 20- and 30-year-olds.
   Young staffers have power and influence, but need your issue expertise.



# Local Advocacy

- State Legislatures are short windows of time
- State Legislators are overworked and underpaid!
- Very little staff or resources stories provide context and research!
- Cities can have just as much impact
- Local Executives are much more approachable than national executives such as secretary or President

#### Federal Update

- **CDC Updates Nursing Home Recommendations.** Read <u>here</u>. CDC has officially changed their vaccination language and considerations related to vaccination status to "up to date" to reflect individuals who have received all recommended COVID-19 vaccinations for which they are eligible. This impacts testing and quarantine following exposure.
- However, CMS has confirmed that nursing homes should continue to follow the latest CMS guidance on testing requirements. Read here. This means that, until further notice, nursing homes may continue to test only unvaccinated staff for routine screening testing and staff who have completed a primary vaccine series, regardless of whether they have received a recommended booster for which they are eligible, may be exempt from routine screening testing. It is unlikely that this discrepancy will last long. CMS will likely move to reconcile the differences between CDC recommendations and CMS requirements soon.





# Legislative Update

#### This week:

- Tuesday, Feb 1 hearing on staffing agency reform bill (HB 2524). Over 20 people attended the hearing to oppose the bill, and both opponents and some committee members were highly critical of the 150% cap on agency charges for long term care providers.
  - Next steps: We are advocating with committee members to do further work on the bill to advance it out of committee and to recognize that the financial instability around staffing and staffing agencies is unsurvivable for our providers.
- Friday, Feb 4 KanCare Oversight committee meets from 9am 4pm today. LeadingAge Kansas will provide testimony on staffing shortages, the need for staffing agency reform, increased funding and expanded C.N.A. training

#### Next week:

We are working with a coalition that plans to introduce a new bill that expands and updates CNA Training programs in the state. Stay tuned!
