Federal Update

Blanket Waivers Terminated Monday, June 6th
Including the nurse aide training waiver, in-servicing waiver, and Physical Environment and Life Safety Code waivers related to temporary spaces and temporary construction to address surge capacity. Read here for more information. Note: All Temp Aides must be certified by October 6th

No Updates to CDC Healthcare Recommendations at This Time

We have been expecting updates to the CDC recommendations for healthcare settings and personnel, but LeadingAge National was notified by CDC today that these updates are on hold at this time. With this in mind, we remind providers of the following:

- CDC recommends that healthcare settings, including nursing homes and assisted living, and healthcare personnel including hospice and home health, follow <u>Interim Infection Prevention and Control Recommendations for Healthcare Personnel</u>.
- Nursing homes can also refer to CDC's <u>Interim Infection Prevention and Control Recommendations to Prevent SARS-CoV-2 Spread in Nursing Homes</u> for more specific information.
- The definition of "up to date" has changed with CDC's strengthened recommendation that individuals aged 50 and older *should* receive a 2nd booster. More information on what "up to date" looks like can be found on CDC's Stay Up to Date page.

Nursing homes should continue to refer to CDC's Community Transmission Rates for determining frequency of routine screening testing of asymptomatic staff and other mitigation measures.
