## State Update

Kansas COVID-19 state of emergency ended Tuesday, June 15th

KDHE officials confirmed that nothing should change for providers, everything available to you during the emergency order will remain in place, including testing and emergency supplies.

All Executive Orders related to COVID-19 are expired. That includes use of temporary nurse aides and mandatory surveillance testing in state-licensed only settings (assisted living, homes plus, residential health care facilities, nursing homes not in Medicaid or Medicare program)

Note: We have heard from KDADS that KDHE and local health departments may be looking for a way to continue the surveillance testing requirements for state-licensed providers

## State Update

- KDADS has audited 15 nursing homes and 5 HCBS providers for use of SPARK funds, with responses due this week. Let us know if you were one of them
