The thing they said they were going to stop was the receiving and counting of sequences performed by states and local labs. They are still counting the sequences that they either do themselves or have their contractors performed.
I was just able to join, was there more info about the LTC outbreaks that were shared earlier?	There are 10 active LTC outbreaks. Most of these are driven by unvaccinated staff.
Most patients are being given monoclonal antibodies before the sequencing results return. What recommendation do you have for providers if monoclonals are not to be administered in the P1 variant but the patient qualifies for monoclonal treatment?	Sequencing does take several days. One strategy would be to evaluate where the P.1 variants are circulating in Kansas and if the patients live in those areas, consider treatment with the REGEN-COV product.
