ATTN: Home and Community Based Services Providers, CMHCs and Nursing Facilities

Sunflower wants to help you stay safe during COVID.

To help stop the spread of COVID-19, we are providing personal protective equipment for you and the individuals you support. We have partnered with a local agency to assist with distributing masks to you. Supplies are limited and free of charge to HCBS, CMHCs and Nursing Facility providers.

Please be prepared to verify the number of individuals you support and the number of employees with direct contact with members

The masks will be available beginning May 7. The following are instructions for accessing them:

- See the table below to identify the location closest to you.
- Check the notes to identify specific location instructions.
- o For all locations, unless noted, call ahead to set up your pickup and ensure materials are still available.
- Please plan to pick up items by May 22nd, as remaining items may be moved to other locations for distribution.

Additional information:

- Most locations are available 8-5, but you need to call ahead.
- Please only send 1-2 staff to pick up items.
- Each provider must bring their own bag or box to load the items into.
- The provider will need to confirm the total number of persons they serve in HCBS services or residents in their nursing facility (these will include Sunflower members as well as members with other payers) and number of employees.
- Providers will be given the number of 3 ply masks up to total individuals supported plus direct contact employees. These are available until masks are gone. This is first come, first served. Please do not complain to the distributing provider as they only have access to the amount we delivered.
- Providers must be prepared to maintain the recommended social distance, such as lining up in cars or • standing in line 6 feet apart, at pick up locations. Specific details will be provided by the pickup location.
- Please do not bring any persons served, in order to minimize the exposure risk to them.

Staff passing out the PPE will use masks and maintain social distancing to protect safety.
